#### ENTRY FEES

First entry of a dog in conformation each show - \$33.00.

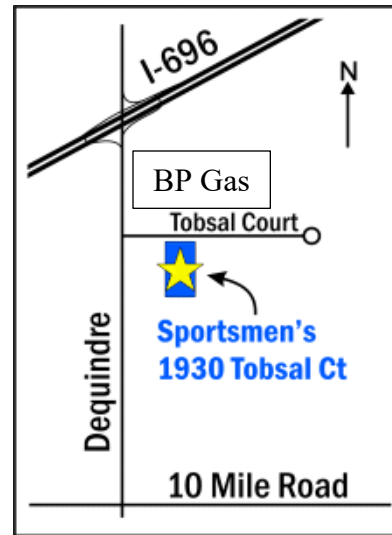
